To ratify the SORK Constitutional Amendments in line with the Radiographers Act No. 28 of

2022

Honorable Members,

Following recommendations of PEILAC and ratification by Council, I hereby move amendments to the Society of Radiography in Kenya Constitution 2018 as follows;

- Insertion of the words; "Registered Under CAP 108 Societies Act, Laws of Kenya on 25 May 1962, Certificate of Exemption No. 1222" immediately below the words "Formerly Association of Radiographers, Kenya (ARK) Founded 1961";
- 2. Amendment to Content Page to reflect:
 - a) Twenty-five (25) bullets instead of twenty-four (4) of itemized components;
 - b) Bullet 5 as Offices of the Society;
 - Bullet 6 as Officers of the Society;
 - Deletion of the words "Standing Committees" and replacing them with the word "Committees";
 - e) Deletion of the words "Change of Office" and replacing them with the words "Leadership Transition"; and,
 - f) Deletion of the words "Auditor's Section" and replacing them with the words "Auditors of The Society";
- 3. Amend Section 1.1 Name to read as follows;
 - a) 1.1.1 The name of this organization shall be the Society of Radiography in Kenya herein abbreviated as SORK and referred to as Society.
 - b) 1.1.2 This Constitution shall therefore be cited as the Society of Radiography in Kenya (SORK) Constitution."

Instead of,

"The name of this organization shall be the Society of Radiography in Kenya herein abbreviated as SORK and referred to as Society. This Constitution shall therefore be cited as the Society of Radiography in Kenya Constitution.

4. Amend Section 1.2 by inserting the words

- a) "Chapter" means a cluster or radiographers with a common recognized radiography modality as shall be or discipline established by these statutes, or as may be approved by Council or the bylaws.
- b) "Committee" means standing committee or a committee set up by the Council to advise and assist it in carrying out its functions.
- c) "Radiographer" means a person registerable under The Radiographers Act No. 28 of 2022, Laws of Kenya or recognized by the Society on reciprocity basis from other jurisdictions.
- d) "Radiography" means the use of radiant energy, ionizing or non-ionizing radiation for medical, forensic, veterinary, industrial and research purposes.

5. Amend Article 2 Objects to read as follows;

- a) 2.1 To advance and maintain the highest professional standards among members.
- b) 2.2 To advocate, educate and research on radiography matters.
- c) 2.2 To advocate for the interests of and motivate the members professionally.
- d) 2.3 To organize and carry out education programmes for its members.
- e) 2.4 To act as a representative body on behalf of members when dealing with any professional body.
- f) 2.5 To create and hold funds which shall be available for furthering the objects of the Society whilst at the same time being a charitable organization
- g) 2.6 To do all such acts and things as may be expedient for the attainment of the above objectives or any of them.

Insert sub Section 3.2.4 to read as follows;

"Pursuant to 3.2.1 above, Council shall provide a policy framework that formally recognizes an organization or organizations of persons undergoing a radiography course of training in at a recognized institution."

7. Amend 4.1.2 to read as follows;

"The Council shall comprise of Officers of the Society, a Vice President and not less than six (6) or more than eight (8) additional members all elected at the general election AGM."

Instead of

"The Council shall comprise of Officers of the Society, a Vice President and not less than two (2) or more than three (3) additional members all elected at the general election AGM."

8. Amend 4.1.3 to read as follows;

"The additional members shall represent the following sectoral interests;"

a)	4.1.3.1	Medical radiographers
b)	. 4.1.3.2	Veterinary radiographers
c)	4.1.3.3	Industrial radiographers
d)	4.1.3.4	Forensic radiographers
e)	4.1.3.5	Radiographers from the private sector institutions
f)	4.1.3.6	Radiographers working for county governments
g)	4.1.3.7	Radiographers working for national government
h)	4.1.3.8 institutions.	Radiographers working for recognized radiography education and training

9. Insert sub Section 4.1.4 to read as follows;

"Council may if deem necessary co-opt an additional member to represent emerging special interest groups."

10. Insert sub Section 4.1.5 to read as follows;

"When no additional member is elected to represent sectoral interests, Council shall act administratively to ensure effective representation of the same."

11. Insert sub Section 4.1.6 to read as follows;

"Pursuant to 4.1.2, Council shall elect a Vice President from amongst the additional member as envisioned in 4.1.3 upon recommendation by the Executive Committee."

This in effect consolidates the offices of First Vice President and Second Vice President into one.

- 12. Amend sub Section 4.1.3 to read as follows: "4.1.7 The immediate Past President and/or Past Honorary Secretary of the Society at the discretion of Council may be co-opted as ex-officio members."
- 13. Retain sub Section 4.1.4 as sub Section 4.1.8
- 14. Retain sub Section 4.1.5 as sub Section 4.1.9

- 15. Amend Section 4.2 and insert sub Section 4.2.1.4 Life Members of good standing with the Society.
- 16. Amend Section 4.2 Paragraph 4.2.1.4 read as Paragraph 4.2.1.5 Ex Officio Members: and read as follows;
 - a) 4.2.1.5.1 the highest ranking radiographer at the Ministry of Health or appointee,
 - b) _4.2.1.5.2 radiographer(s) responsible for service delivery in teaching and referral hospitals in the country or their representatives,
 - c) 4.2.1.5.3 a radiographer responsible for radiography education and/or training at public institution; and,
 - d) 4.2.1.5.4 a radiographer responsible for radiography education and/or training at public institution.

Instead of

"Chief Radiographer Ministry of Health or appointee, Chief Radiographer(s) for Teaching Hospitals in the country or representatives, and the Director of public radiography training."

- 17. Retain Paragraph 4.2.1.5 as 4.2.1.6 and insert the words "of good standing" between the words "members" and "in".
- 18. Amend 4.2.3 to read as follows;
 "The CF shall review and ratify fiscal planning and budgetary allocations proposals from Council."
- 19. Retain sub Section 4.2.3 as to read as sub Section 4.2.4
- 20. Retain sub Section 4.2.4 as to read as 4.2.5
- 21. Insert sub Section 4.2.6 to read as follows;

 "Pursuant to 4.2.4 such decisions shall be ratified and endorsed by a simple majority at the subsequent AGM."
- 22. Amend Article 5 Offices and Officers of the Society to read as follows;

"Offices of the Society"

23. Amend Article 6 Duties of Officers to read as follows; Officers of the Society

 "The officers of the Society shall be accountable to Council and membership individually and/ or collectively."

- 27. Delete Sections 6.2 and 6.3 consolidate to be read as Article 7.2 Vice President
- 28. Retain Section 6.4 as Section 7.3

 "Any member of Council or CF may resign at any time by giving notice in writing to the Honorary Secretary."

"Branches and chapters of the Society may be formed following application to and approval by Council and will be run under the supervision of the Council and in accordance with the rules laid down in the by-laws."

"Branches of the Society may be formed following application to and approval by Council and will be run under the supervision of the Council and in accordance with the rules laid down in the bylaws."

26 Transitional Sections

26.1 General Provisions

26.1.1 Suspension of Provisions of this Constitution

- **26.1.1.1** The following provisions of this Constitution are suspended until the final ratification of this Constitution by the Registrar of Societies
 - **26.1.1.1.1** Article 4, except that the provisions of the Article shall apply to the first general elections under this Constitution; and,
 - **26.1.1.1.2** Article 18 Section 6, except that the provisions of the Article shall apply to the first general elections under this Constitution.
- 26.1.2 Until Council or a general meeting passes the by-laws anticipated in the operationalization of this Constitution, by-laws the former Constitution continues to apply.

26.2 Transitional and Consequential Provisions

- 26.2.1 Council shall develop and enforce any by-laws required by this Constitution in the order prescribed in Schedule 1 commencing on the effective date.
- 26.2.2 Despite Section (1), Council may, by resolution supported by the votes of at least twothirds of all the members of Council, extend the period prescribed in respect of any particular matter under Section (1), by a period not exceeding one year.
- 26.2.3 The power of the Council contemplated under Section (2), may be exercised only once in respect of any particular matter; and only in exceptional circumstances to be certified by the Consultative Forum.

26.3 Effective Date

This Constitution shall come into force on its promulgation by the Registrar of Societies or on the expiry of a period of three months from the date of the approval of this Constitution by a general meeting, whichever is the earlier.
